End-User License Agreement

IMPORTANT - READ CAREFULLY: This End-User License ("License") is an agreement between you, an individual and/or entity ("Licensee") and ERI Economic Research Institute, Inc. ("ERI") and/or PAQ Services, Inc. ("PAQ") governing respectively your use of the specific ERI and PAQ products, including any updates, upgrades, fixes, and renewals, provided to you by ERI, PAQ or their distributor (each a "Licensed Product") or by any licensed user such including BTA, SalariesReview, or Abbott, Langer Associates surveys. ERI and PAQ are each a "Licensor" with respect to their respective products. ERI products may include, without limitation, the Assessor Series® and ERI's Platform Library® software, databases, including the Salary Assessor®, Geographic Assessor®, Executive Compensation Assessor®, Relocation Assessor®, Occupational Assessor™, Nonprofit Comparables Assessor™, eDOT Skills Project, quarterly reports, annual reports (including any Reference Reports™); the ERI Distance Learning Center software, the DLC Wizard®; SalariesReview Surveys, Abbott, Langer Associates surveys, Global Salary Calculator PRO+ software, SalaryExpert Premium Salary Reports®, products accessed or downloaded through ERI Internet sites (including without limitation, <http://www.erieri.com>, <http://www.erieri.co.uk>, <http://www.salariesreview.com>, <http://www.eri-salary-survey.com>, <http://www.eri-executive-compensation.com>, <http://www.eridlc.com>, and <http://www.eri-nonprofit-salaries.com>). PAQ products may include, without limitation, PAQ's eDOT Skills Project and the enhanced Dictionary of Occupational Titles® (the databases collectively referred to as "eDOT®") and products, web services, and reports accessed or downloaded at PAQ's Web site at <http://www.paq.com> including ERI's Occupational Assessor.

BY CLICKING ON THE "I ACCEPT" BUTTON, ENTERING A LICENSE CODE, OR OTHERWISE INSTALLING AND USING ANY OF THE LICENSED PRODUCTS, LICENSEE ACKNOWLEDGES THAT LICENSEE HAS READ THIS LICENSE AND AGREES TO BE BOUND BY ITS TERMS. IF A SURVEY PRINTED OR PDF SURVEY REPORT, LICENSEE ACKNOWLEDGES THAT BY OPENING THE SHRINK WRAPPED PRODUCT OR PDF, THE SAME TERMS AND CONDITIONS APPLY. IF LICENSEE DOES NOT AGREE TO THE TERMS OF THIS LICENSE, LICENSEE MAY NOT INSTALL OR USE THE COVERED PRODUCTS AND LICENSEE MUST RETURN THE LICENSED PRODUCT IMMEDIATELY.

1. LICENSE.

a) Grant. Each Licensor hereby grants to Licensee a personal, non-exclusive, non-transferable license to install, use, copy and display its respective Licensed Product and any Updates (defined below) solely for Licensee's (a) internal business and human resource management purposes; (b) specific client work performed in the forensic economics, management, vocational, compensation & benefits consulting; and (c) rehabilitation consulting, accounting, law, and litigation support where the maintenance of reports and the citing of foundation for opinions are required.

b) Updates. If Licensee has purchased the Assessor Series or eDOT, Licensee will receive during the effective term of this License updates to the underlying data for such Licensed Products ("Updates"). The Updates will be provided on a periodic basis via CD-ROM, Memory Key or via the Internet. Because Updates are time sensitive, Licensee acknowledges and agrees that Licensee may only access and use an Update for a period of ninety (90) days following the release date of the Update unless the License expires or is terminated prior to the end of such period. For illustration purposes only, a quarterly Assessor Series program update with a release date of 1 October 2007 may not be accessed after 31 December 2007 or upon the termination or expiration of the License, whichever occurs earlier. Archival surveys that contain a limited amount of Assessor Series data are available via the www.salariesreview.com website.

c) License Term; Termination. Licensed Products are licensed for an initial 12-month period ("Initial Term"). This License shall automatically renew for successive one-year terms unless either a Licensor or Licensee gives written notice of termination at least thirty (30) days prior to end of the Initial Term or any subsequently renewed term thereafter. Licensor may send Licensee notices

relating to the Licensed Products and affiliated projects of Licensor. Licensee must pay for the applicable subscription fees within 30 days of receipt of the Licensed Product and upon each renewal. Without prejudice to any other rights, a Licensor may terminate or suspend this License if the Licensee fails to comply with the terms and conditions of this License. Upon the expiration or termination of this License, the Licensee must destroy all copies of the Licensed Products and all of its component parts. SalariesReview Archival Surveys do not require a License Code and are expected to be retained indefinitely for referral purposes in Licensees' libraries. Archival surveys and programs that contain a limited amount of Assessor Series data available via the www.salariesreview.com website may be placed in one's library for perpetuity.

2. CONDITIONS AND RESTRICTIONS. The license grant above is subject to the following conditions and restrictions:

a) Permitted Copies; Archives. Subject to the exceptions described in this paragraph, only one copy of the Licensed Product (excluding SalariesReview archival surveys) may be used by Licensee (or a designee of Licensee) and installed on a single computer at a single geographic location at any given time (the "Permitted Computer"). Memory Keys may be used with more than one computer, but files installed by Licensor to the Memory Keys may not be copied to any computer or otherwise duplicated for use by anyone other than the Licensee. Licensee may make archival files of reports or other data component of the Licensed Product using the "print" or "copy to clipboard" options. Notwithstanding the foregoing, Licensee may not install or use the Licensed Product on any other computer or shared network (including but not limited to Local area network (LAN) or wide area network (WAN)) unless Licensee has purchased a network user license from Licensor. Each network user shall be treated as a separate Licensee. Licensee may copy and incorporate small excerpts of the Licensed Product solely for a Licensed Use; provided that, Licensee may not otherwise reproduce or distribute any part of the Licensed Product (including any reports, data, and/or analyses contained therein) for any commercial purpose without the written consent of the Licensor.

b) Notices. All copies of the Licensed Product shall contain all copyright and other proprietary notices or legends of Licensor or its vendors that are contained in the Licensed Products delivered under this Agreement and Licensee may not remove any such notices. In creating any copy of any portion of the Licensed Product, Licensee must reproduce and include the Licensor's copyright notices in and on the copy.

c) No Unauthorized Uses. The Licensed Product is licensed as a single product and its component parts may not be separated for use for any purpose. Except as expressly authorized by this License, Licensee shall not rent, sell, assign, transfer, lease, sublicense or otherwise grant rights in, reproduce, publish, act as a service bureau, disclose or otherwise transfer or distribute the Licensed Product, in whole or in part, to any third party without the prior written consent of Licensor. Without limiting the foregoing, Licensee shall not use any part of the Licensed Product to develop or derive any other data product or data service for distribution or commercial sale, without a separate license from the Licensor. To track unauthorized users, Licensee agrees that the Licensor may maintain and collect an Internet log in order to track Licensee's use of the Licensed Product.

d) No Reverse Engineering or Data Extraction. Except and only to the extent that such activity is expressly permitted by applicable law, the Licensee may not, nor authorize or permit any third party to, reverse engineer, reverse assemble, decompile, disassemble or otherwise apply any procedure or process to the Licensed Product to ascertain, derive, and/or appropriate for any reason or purpose, the source code, algorithms, underlying data, or trade secrets enabling or contained within the Licensed Product.

3. The Occupational Assessor, also called eDOT - the enhanced Dictionary of Occupational Titles.

a) eDOT Disclaimer. Licensee acknowledges that (a) eDOT (including any software, data, reports, and the eDOT Skills Project) is designed for use by qualified, experienced job analysts and experts; (b) eDOT and Licensee's use of eDOT is expressly subject to the "eDOT Disclaimer" (accessible in the software via the "Disclaimer" button or the "Help | Disclaimer" menu and is also available at <http://www.paq.com>; (c) Licensee has reviewed and is familiar with the eDOT Methodology posted at <http://www.erieri.com/PDF/eDOTMethodology.pdf>; and (d) Licensee is solely responsible and assumes all risk of loss and liability for Licensee's evaluation, use and application of the Licensed

Product, eDOT, and any associated data, results, or analyses of any Licensed Product. The eDOT Methodology as it presently exists and as hereafter amended or modified is also incorporated herein.

b) Indemnification. Licensee shall hold harmless, defend and indemnify Licensor, its affiliates and their respective employees, officers, directors and representatives individually and/or in their employment/corporate capacity (collectively, the "**Indemnified Party**") against any and all claims, actions, proceedings, and/or lawsuits (collectively, a "**Claim**") and all related liabilities, damages, settlements, penalties, fines, costs or expenses (including reasonable attorneys' fees and other litigation expenses) incurred by an Indemnified Party arising out of or relating to Licensee's alleged or actual use of eDOT or other Licensed Product, including, but not limited to, any determinations made by Licensee regarding (a) any person's right or ability to receive benefits associated with a workers' compensation or disability claim, (b) levels of compensation, or (c) comparable or transferable job skills.

Without limiting the foregoing, in the event of any Claim or should an Indemnified Party be compelled or contacted to participate in any dispute, litigation, hearing or other proceeding of any court, arbitration panel, administrative agency or similar entity on behalf of Licensee, the panel or any third party regarding Licensee's use of eDOT or other Licensed Product (an "Action"), the Licensee shall be responsible to the Indemnified Party for any and all costs and expenses of the Indemnified Party, including, but not limited to, attorneys fees, administrative and travel expenses, and the Indemnified Party's hourly fees for such participation (including all time spent in preparation, research, travel, testifying, drafting and waiting time). The hourly rate shall equal the annualized salary of the individual participating on behalf of the Indemnified Party multiplied by four (4) divided by 1,000 hours. Promptly upon receipt of the Indemnified Party's notice of such an Action, Licensee shall pay to the Indemnified Party a deposit of \$10,000 to be used by the Indemnified Party for its costs and expenses. Until the Action is completed or the Indemnified Party's participation is concluded, Licensee shall within five (5) days of the end of each month, (a) replace any funds used to maintain the balance of the deposit at \$10,000, and (b) in the event the Indemnified Party's costs and expenses exceed the amounts in the deposit, pay to the Indemnified Party such shortfall. Within thirty (30) days of receipt of Licensee's written certification that the Action is completed or the Indemnified Party's participation is concluded, the Indemnified Party shall refund any undisbursed amounts retained in the deposit.

i. Procedure. In the event of a Claim or Action brought by a party, the Indemnified Party shall do the following: (a) the Indemnified Party shall provide to the Licensee written notice of any such Claim after Indemnified Party's receipt of notice of the Claim; (b) the Indemnified Party shall grant to Licensee, and the Licensee will have, the exclusive right to defend any such Claim and make monetary settlements thereof at Licensee's discretion; (c) the Indemnified Party shall not settle or compromise such Claim, except with prior written consent of Licensee; and (d) the Indemnified Party shall give, at Licensee's expense, such assistance and information as Licensee may reasonably require to settle or oppose such Claims. The Indemnified Party may participate in the defense or settlement of such Claim with its own choice of counsel.

ii. Third Party Beneficiaries. The parties intend that ERI and its Affiliates and their respective employees, officers, directors and representatives, shall be express third-party beneficiaries to these indemnification provisions and shall have the right and ability to enforce its rights and remedies hereunder. These indemnification provisions are not otherwise intended to confer upon any person, any other rights or remedies hereunder.

iii. Term & Continuation. The provisions of these indemnification provisions apply during the current term of Licensee's ERI Product license and any renewals thereof, and survive and continue indefinitely beyond the expiration of Licensee's ERI Product license.

c) Participation. Licensee agrees (1) to participate in ERI's SalariesReview's surveys and the eDOTSkills Project, including providing feedback and changes of eDOT, (2) by accessing eDOT, Licensee's input may change the eDOT database, (3) any feedback, comments or data submitted to Licensor shall become the exclusive property of Licensor, and (4) Licensor may track and monitor Licensee's use of eDOT and other Licensed Products.

Licensee shall not take any action to jeopardize, limit or interfere with Licensor's ownership of and rights with respect to the Licensed Product and shall not take any action that reduces, or has the possibility of reducing, the value of the Licensed Product or intellectual property of Licensor. Licensee acknowledges that any unauthorized copying or unauthorized use of the Licensed Product is a breach of this License. The Licensee agrees to keep confidential and prevent the contents of the Licensed Products from unauthorized use and disclosure.
